Area 1 (Inside) Licensed for 50 guests

Area 2 (Outside under extendable awnings) Licensed for 35 guests

Area 3 (Outside Marina Circle) Licensed for 45 guests

Area 1 and 2 are available for combination for larger functions of up to 85, however strict licensed numbers in each of the two areas cannot exceed legal licensed numbers in that area. Conditions apply for hiring out each of the areas and minimum spends may apply.

Oysters Natural \$40 - Fresh Natural Oysters Served with fresh lemon.

Oysters Kilpatrick \$50 – Grilled Oysters with our mix of bacon, Worcestershire and tomato sauce

Oysters Mixed Platter \$70 – Your choice of any four varieties of oysters (Grilled or Chilled)

8 Pieces	5 People
10 Pieces	4 People

FUNCTION TERMS AND CONDITIONS

Booking Confirmation

Once a tentative booking has been made, your total room hire (or otherwise agreed amount), must be paid to confirm your booking. Tentative bookings will be held for 7 days only. After such time, management reserves the right to cancel your function and re-allocate your area without notice.

Cancellations

Confirmed bookings cancelled 21 days or less prior to the event will lose their full deposit. Cancellations 7 days prior to the event will lose full payment.

Area Costing

Area 1 (Inside) Licensed for 50 guests \$175

Area 2 (Outside under extendable awnings) Licensed for 35 guests \$75

Area 3 (Outside Marina Circle) Licensed for 45 guests \$175

You may book a combination of Area 1 and 2 for functions up to 85 guests, however guest numbers in each of the areas cannot exceed the specific licensed number for each of the areas. Minimum costs may apply to your booking depending on the time and day during peak season.

Final Numbers

Numbers must be confirmed 7 days prior to the function. Numbers given at this time will be considered final and the hirer will therefore be deemed responsible to pay the full amount booked for, barring extenuating circumstances. As The Oyster Bar does not have specific private function rooms for hire, we therefore offer areas of the restaurant for hire, if final numbers do not exclusively fill the number of licensed guest in a particular area, then part of that area will be made available for public use due to the nature of the limited space available for use. We will ensure that any area or partial area you hire will be made private to you and your guests to ensure you have a dedicated area for use for your function.

Menu Selections

We ask that all catering requirements be confirmed with your Event Manager no less than 7days prior to your function. No food or beverages may be brought into The Oyster Bar for consumption during an event unless prior authorisation has been sought (cakes excluded).

Start and End Times

Start and end times must be estimated at the time of the booking and confirmed no later than 5 days prior to the function, at the time of selecting food and wine. The bar closes at 11:30pm (Monday to Thursday), 12:30am (Friday –Saturday) and 11:00pm on Sunday. Departure times must be strictly adhered to and guest need to vacate the premise 15 minutes after the bar closes. Management reserves the right to enforce closing time at any point during your function.

Price Variations

Every endeavour is made to maintain prices as published, however prices are subject to change without notice. All prices are GST inclusive. It is the responsibility of the organiser to ensure they have an up to date Function Price List.

Subsidised Drinks

A subsidised drink tab means that your guests pay an agreed amount towards specified drinks on your bar tab and the remaining cost will be charged to your account.

Entertainment

The Oyster Bar management has the right to approve all musicians, DJ's or bands prior to the function. CD's and IPods which are compatible with our sound system may be used. The sound system is operated by The Oyster Bar staff as all times. Entertainment is permitted in the inside area only.

Photos

Photo footage can be displayed on inside plasmas but must be supplied to the venue 7days prior to the function and must be supplied in Jpeg single photo format.

Delivery/Pickup of Goods

The Oyster Bar will not accept responsibility for damage to or loss of goods. All goods belonging to persons attending a function must be claimed and removed from the venue within 24 hours. Organisers should also advise the Function Coordinator of any goods being delivered to the premise. The function organisers are financially responsible for any damage sustained to the property by organisers, or guests of the organiser.

Inappropriate Behaviour and Responsible Service of Alcohol

The Oyster Bar reserves the right to expel any person or persons who behaves in an objectionable manner. We also reserve the right to expel anyone deemed intoxicated from the venue or under the age of 18 years of age after midnight. Any guests found supplying alcohol to minors or any minors found consuming alcohol will be expelled from the premise immediately.

Weather

The Oyster Bar will not take any responsibility for the weather, if booking outside you do so at your own risk. The Venue will not guarantee an alternative exclusive area, though should one be available at the time it will be made access to you and your guests.

Insurance

The Oyster Bar will not be held responsible or pay any premiums on any insurance policies against injury, damage to or loss of equipment, merchandise or personal property of guests left on the premises prior to, during or after a function.

Payment of your Account

Full function payments are required on the day of the event. Preferred payment is by cash or bank cheque; however we do accept Visa, MasterCard and AMEX. Personal cheques are also accepted providing credit facilities have been pre-established.
